## Abstract.

To assess nurses' knowledge, attitude and practices about the elderly health needs in the four different health settings in Cairo, data were obtained from 50 nurses chosen randomly according to the total number of the nurses in the study settings, 5%, 10% and 100%. There was marked lack of knowledge with some negative attitude towards the elderly in general and towards the elderly health needs in particular as well as less quality of performance, which may enhance the effect of the programmed self- learning package (PSLP). On conclusion, the development and implementation of the in-service educational program (PSLP) about elderly health and the nursing measures needed for this specific age were very much effective in the nurses' knowledge, attitude and practices.
