Abstract:

The emergence of cyber-cultures and the formation of cyber-communities is one of the most prominent and controversial issues raised by the globalization and the advent of Information and Communication Technology. Lying on the borders between the virtual and the real, such emerging cultures and communities became controversial as they challenge all the well-established notions of *culture* and *community*. Moreover, Cyberspace challenges our traditional understanding of notions as basic as time, space, and—more importantly—identity. A new inquiry arises questioning how social identity would be redefined in the context of such emerging communities based on cyberspace conceptual and technical features. We depicted the scientific construction and perception of social identity in cyberspace in conjunction with Social Identity Theory. A comparison of both online and

offline lives is conducted and the effect of the involvement in online communities on users' affiliation to the offline life is also investigated. The two notions of cyber-compatriotism and cyber-citizenship are given special care to find some intersection, differentiation and integration zones.

Summary:

The rapid development and proliferation of new information and communication technologies has given rise to a lively debate and a growing literature on the changes that occur to the users of such technologies.
